- 2.01 Bidder accepts all of the terms and conditions of the Advertisement or Invitation to Bid and Instructions to Bidders, including without limitation those dealing with the disposition of Bid security. The Bid will remain subject to acceptance for 60 days after the Bid opening, or for such longer period of time that Bidder may agree to in writing upon request of OWNER.
- 3.01 In submitting this Bid, Bidder represents, as set forth in the Agreement, that:
 - A. Bidder has examined and carefully studied the Bidding Documents, the other related data identified in the Bidding Documents, and the following Addenda, receipt of all which is hereby acknowledged.

- B. Bidder certifies Bidder is qualified to do business in the state where the Project is located as required by laws, rules, and regulations or, if allowed by stature, covenants to obtain such qualification prior to contract award.
- C. The Bidder shall provide values for specific performance parameters for the equipment being bid. The Bidder understands and agrees that the values stated in this Section for the associated performance parameters will be compared to the performance standards required in the equipment specifications. Bidders understand and agree to guarantee the performance values stated herein for the equipment bid in accordance with the guidelines specified herein.
- D. Bidder understands and agrees that this PROPOSAL shall form the basis for an agreement with the OWNER. Therefore, the undersigned agrees to enter into an agreement to perform and furnish all Work as specified or indicated in these Specifications for the amount indicated in this Bid and in accordance with the other terms and conditions of these Contract Documents.
- E. Bidder accepts all of the terms and conditions of these Contract Documents including, without limitation, those dealing with the disposition of Bid security, required bonds, and the liquidated damages that may be imposed. This Bid shall remain subject to acceptance for a period of 60 days after the day of Bid opening. The Bidder shall sign and submit the Agreement with the bonds and other required documents within 10 days after the receipt of Notice of Award from the OWNER.
- F. Bidder has given ENGINEER written notice of all conflicts, errors, ambiguities, or discrepancies that Bidder has discovered in the Bidding Documents, and the written resolution thereof by ENGINEER is acceptable to Bidder.
- G. The Bidding Documents are generally sufficient to indicate and convey understanding of all terms and conditions for the performance of the Work for which this Bid is submitted.

- 4.01 Bidder further represents that this Bid is genuine and not made in the interest of or on behalf of any undisclosed individual or entity and is not submitted in conformity with any agreement or rules of any group, association, organization or corporation; Bidder has not directly or indirectly induced or solicited any other Bidder to submit a false or sham Bid; Bidder has not solicited or induced any individual or entity to refrain from bidding; and Bidder has not sought by collusion to obtain for itself any advantage over any other Bidder or over OWNER.
- **5.01** Bidder will complete the Work in accordance with the Contract Documents for the prices bid in the following Lump Sum Bid Schedule.
- **6.01** Bidder agrees to accept Contract Times as set forth in the Agreement.
- **6.02** Bidder accepts the provisions of the Agreement as to liquidated damages in the event of failure to complete the Work within the Contract Times specified.

SAFETY SHOWER AND EYEWASH

PART 1 GENERAL

1.1 SECTION INCLUDES:

A. Manufactured and assembled safety shower/eyewash assembly.

1.2 SAFETY SHOWER EYEWASH:

Unit shall be a complete assembly consisting of a drench-type shower head, pull rod operated shower valve, eye/face washing station, and ball valve, and floor stand. Valves shall be stay-open type. Furnish ANSI sign.

PART 2 PRODUCTS

2.1 MANUFACTURERS:

- A. Haws Model 8317.
- B. BLS Industries ES-3-BNH.
- C. Approved equivalent.

2.2 CODE COMPLIANCE:

A. Unit shall comply with Applicable American National Institute (ANSI) and Occupational Safety and Health Administration (OSHA) Requirements.

PART 3 EXECUTION

- 3.1 Install piping accessories with thread compound and ensure that all the eyewash and all accessories are free of leaks.
- 3.2 Install unit plumb as shown. Floor plate to rest on grout base and stainless steel concrete anchors.
- 3.3 Do not connect unit to building piping until the building piping has been flushed clean.
- 3.4 Demonstrate proper operation of unit.
